

# Terms and Conditions

These Terms and Conditions ("Terms") govern your use of FeatBit, an open-source feature flag platform ("Service"), operated by FeatBit Inc ("we," "our," or "us"). By accessing or using FeatBit, you agree to comply with these Terms. If you do not agree to these Terms, you may not use the Service.

## 1. Acceptance of Terms

By using FeatBit, you acknowledge that you have read, understood, and agree to be bound by these Terms and any applicable laws or regulations.

## 2. Use of Service

FeatBit is an open-source platform for managing feature flags in your applications. You may use the Service to integrate feature flags within your software, subject to the following conditions:

- You agree not to misuse the Service or use it for illegal or harmful purposes.
- FeatBit is provided under the **MIT License**, which allows you to modify, distribute, and use the Service freely, subject to the terms of the MIT License.
- For advanced features, a separate [FeatBit SAAP License Agreement](#) may apply. Please review the agreement for specific terms related to advanced features.
- You are responsible for maintaining the security and confidentiality of any data you provide while using the Service.

## 3. License

FeatBit is provided under the **MIT License**. You are free to use, modify, and distribute FeatBit in accordance with the terms of the MIT License.

For advanced features, the use of certain functionality may be governed by the [FeatBit SAAP License Agreement](#). Please refer to the separate agreement for detailed licensing terms concerning these features.

## 4. User Account

You may be required to create an account to use some features of the Service. You are responsible for providing accurate information and for maintaining the confidentiality of your account credentials.

## 5. Privacy and Data Collection

We collect and process personal data in accordance with our [Privacy Policy](#). By using the Service, you consent to our data collection practices as described in the [Privacy Policy](#).

## 6. Restrictions

You agree not to:

- Use the Service for any unlawful purposes or in violation of any applicable laws.
